



**Statistics and Outcomes: Report on UK Applications  
and Awards for Archive Service Accreditation  
(June 2023-May 2024)**

This report offers an overview of how Archive Service Accreditation is progressing across the UK since its launch in June 2013, with a particular focus on the period June 2023 to May 2024. It also outlines how applicant archive services have achieved against the standard both at module and at requirement level within the assessment framework.

The report is based on the total number of applications reviewed for Archive Service Accreditation by an Archive Service Accreditation Panel. Any applications whose review was deferred by a Panel, are included in Sections 1-3 of the report only (Applications for Archive Service Accreditation and type of applicant archive services), as these applications do not have a confirmed outcome or assessment.

Since the launch of Archive Service Accreditation in June 2013, 282 archive services have completed an application for Archive Service Accreditation across the UK. This figure includes archive services who may have made a first unsuccessful application but who were subsequently accredited. Of the applicants, 207 were making an application for an initial award and 75 were accredited archive services making a second application to retain accredited status after the initial six-year award.

The number of new applications has continued to drop since the peak of the initial rollout in 2017/2018 as those archive services identified as priority applicant groups in England and Wales (Places of Deposit) have largely applied for accreditation. It is also worth noting that 2019/ 2020 also saw the first cohort of accredited archive services make their second application for Archive Service Accreditation according to an agreed application schedule. The number of archive services making their second application continues to increase and this reflects the initial rollout of the programme.

During 2020/2021 and 2021/2022 the programme was impacted by the COVID 19 pandemic and associated national restrictions. Following a decision by the Archive Service Accreditation Committee in May 2020, new applications were suspended. In November 2020 the Accreditation Committee agreed that individual home nation assessor bodies should address any new applications, or assess any suspended applications, according to their resources and any restrictions in place. Since then, there has been a gradual resumption of pre-pandemic operations for both applicant services and assessor

bodies. The number of new applicants is slowly increasing reflecting the return to business as usual following the COVID 19 pandemic.

## 2) Applications for the Review Stage of Archive Service Accreditation

The Review Stage is a 'check in' for archive services three years after the initial award of accreditation. Archive services report to their home nation assessor bodies on any changes since the award of Accreditation, for example changes in resourcing, structure, premises or new or revised policies and plans surrounding collections and access. Review Stage applications are made within an agreed timescale with the assessor body.

As noted above there has been some delay in Review Stage applications due to COVID 19 pandemic but despite this the number and pattern of Review Stage applications continue to reflect the trend of initial rollout of the programme.

## 3) Applications by type of archive service

Archive Service Accreditation uses [scalability](#) to identify the types of archive service applying for accreditation and to outline the expectations for different types and sizes of archive service. We share the breakdown of types of archive services according to that scalability here. These include first time applications and second time applications from accredited archive services

In 2023/2024 applications were again dominated by accredited archive services making their second application for accreditation – twenty nine out of thirty eight archive services. Almost all these services belonged to the group *Local Authority Type 2* and reflects the initial rollout of accreditation where application cohorts were dominated by *Local Authority Type 2*.

In terms of new or first-time applications for accreditation, during 2023/2024 applications were received from a broad range of archive services, in particular smaller archive services, both public and private, including archive services in museums, small specialist repositories, a small business archive service, university archive services and the first digital only archive service. This reflects a move away from the initial rollout of accreditation where applications were dominated by *Local Authority Type 2 services* as noted above.

#### 4) **Number of validation visits undertaken by home nation assessor bodies**

When assessing an application for Archive Service Accreditation, assessor bodies can also make a visit to the applicant archive service. This is an opportunity for the assessor to validate elements of the application, review any documentation not suitable to be submitted as part of the application, and also to view the site.

The home nation assessor bodies are:

- The National Archives (TNA) for England
- Public Record Office of Northern Ireland (PRONI) for Northern Ireland
- National Records of Scotland (NRS) and Scottish Council on Archives (SCA) for Scotland
- The Welsh Government (WG) Culture & Sport division, for Wales

These figures include both onsite and virtual validation visits (team meetings) although in reality very few virtual visits took place as assessors returned to onsite visits following the COVID 19 pandemic.

In England, where the policy is to visit a minimum of 25% of applicant archive services at each round, The National Archives achieved 100 % visits by the assessment team to applicant services. Similarly in Wales, the Welsh Government and the Scottish Assessor Bodies achieved 100% visits by the assessment teams.

Validation visits are most often made at Review Stage in cases where not all sites of an archive service were visited during the initial assessment for the award or where there has been significant change to premises. The high percentage of visits in England partly reflects those services that were initially accredited during the COVID 19 pandemic restrictions when no onsite visits were undertaken but enough known about the service to make an award of accreditation.

#### 5) Number of archive services awarded accredited status

The Archive Service Accreditation Panel approves the award of Archive Service Accreditation. There are three potential outcomes:

- Accredited: The archive service has demonstrated that it meets the standard
- Provisionally Accredited: The archive service is close to meeting the requirements of the standard. Provisional Accreditation is awarded for up to two years so one or two significant areas of development can be addressed.
- Not Accredited: The archive service requires development in significant areas to meet the standard.

During 2023/2024, thirty-three services were awarded full accreditation by the Archive Service Accreditation Panel and five archive services were awarded provisional accreditation. Of those services awarded full accreditation eight were initial awards.

### 6) Removal of Archive Service Accreditation

The award of Archive Service Accreditation can be withdrawn from an accredited archive services under exception circumstances. These include:

- Where an archive service no longer meets the eligibility criteria
- Where the archive service no longer meets the standard
- Non-participation in routine reporting for Archive Service Accreditation
- Extraordinary removal of Archive Service Accreditation in by the Committee

Archive Service Accreditation was not withdrawn from any archive service this year.

## 7) **Achievement at module level of Archive Service Accreditation**

Each application receives an overall assessment for each of the three modules within the Accreditation standard, in addition to a detailed assessment against each requirement or sub-requirement. A 'Not Met' in any module makes Accreditation impossible to award.

Thirty-six of the applicant archive services met the standard overall for Organisational Health and two applicants partially meet this module overall.

Thirty-four of applicant archive services met the Collections module overall while four archive services were assessed as partially meeting this module. This is the module where applicant archive services performed least well this year.

Thirty-six of the applicant services met the module for Stakeholders and their Experiences overall here with two services assessed as partially meeting the standard here.

The table below illustrates those areas where applicant archive service performed strongly and less strongly against the standard since the launch of Archive Service Accreditation in 2013.

## 8) **Achievement at requirement level of Archive Service Accreditation**

Each application also receives a specific assessment against each requirement or sub-requirement of the standard. This allows a more in-depth analysis of how an archive service performs against each element of the standard.

### a) **Requirements for Module: Organisational Health**

Organisational Health assesses those areas that underpin the long-term acquisition, preservation and accessibility of archive collections.

In this module 1.4 Premises continues to be the weakest area. Where archive services did not satisfy this requirement fully this was due to a lack of sufficient, secured space for storing collections, either analogue or digital, and in some cases a lack



of appropriate staff or public space as well. However, archive services have performed less satisfactorily against requirement 1.3 during 2023/2024 than in previous years and in some cases forward planning has been absent since the COVID 19 pandemic. Requirement 1.6 is similarly an area of increasing concern compared to previous years.

**b) Requirements for Module: Collections**

The Collections module examines an archive service’s capability to develop, maintain information about and care for its collections.

In this module applicants performed least well overall against Collections Care Procedures (2.4.3). Here 45 % of applicant services were assessed a partially meeting this requirement. This particularly highlights those cases where there are poor storage conditions but where archive services are successfully managing risk (2.4.3) and those cases where there was a need to improve risk management around digital preservation but storage for analogue collections was well managed. One service was apparently assessed as not meeting this requirement.

37 % of applicant archive service were assessed as partially meeting requirement 2.3.2 Collections Information Planning reflecting large cataloguing backlogs.

**c) Requirements for Module: Stakeholders and their Experiences**

This module checks an archive service’s ability to provide and develop access to its collections, in response to its community’s needs.

Archive services continue to perform most strongly in this module overall and in particularly against requirements 3.3.1 Access Policy, 3.3.2 Procedures for user access and 3.3.3 A variety of means of access of available. Applicant archive services tended to perform slightly less well against requirement s3.3.2 Planning for access and engagement and 3.2.1 Understanding and Analysing Audiences.

## 9) Review Stage

As part of the Review Stage application, accredited archive services report any changes to their archive services, for example in resourcing, restructuring, forward planning, and any revised policies. This means the original assessment against each requirement can potentially change.

The tables below show where changes were made to the original assessment at the Review Stage.

Twenty archive services submitted a Review stage application satisfactorily and all of these archive services retained their accredited status, including one archive service that moved from provisional to full accreditation.

There were eight changes at module level across Organisational Health and Collections and Stakeholders and their Experiences. Here four archive services moved from partially to fully meeting the Collections Module overall, whereas two services moved from fully meeting to partially meeting the same module. Three archive services moved from fully meeting to partially meeting the Stakeholders and their Experiences module overall.

Changes in assessment from partially met to met were spread across requirements for all three modules with most changes noted for requirements 2.2.2, 2.4.2, 2.4.4 and, reflecting progress in these respective areas since the initial award of accreditation.

Changes in assessment from met to partially met were likewise spread across requirements for all three modules with most changes noted for requirement 1.3, 1.4 and 2.2.2.

#### **10) New Improvement and Required Actions at Review Stage 2023 to 2024**

In some cases, accredited archive services are given additional improvement and required actions at Review Stage by the assessor. These tend to be much fewer than at the full application stage.

New required and improvement actions are distributed across the whole standard for the year 2023/2024, although with a slightly greater number for those requirements in the module 'Organisational Health'.

### 11) Provisional Status Reviews

Archive services may be awarded provisional accreditation for up to two years either following an assessment for a full application for accreditation or at review stage if it is felt that there is a particular area for improvement before full accreditation. Archive services are asked to report against particular actions as part of the review of their provisional status. The outcome may be a move to full accreditation, retain provisional status until review stage or removal of accreditation.

During 2023/2024 one archive service that was initially awarded provisional status successfully moved to full accreditation.
