

## Terms and Conditions for the use of Manage Your Collections (MYC) Tool

# Copyright and licensing:

The copyright in the catalogue descriptions submitted to Discovery through MYC rests with the contributing institutions. Please ensure that you have the right to submit your content, and have not copied someone else's copyright work without their permission. Contributing institutions agree to make submitted catalogue descriptions available under the terms of the <a href="Open Government Licence">Open Government Licence</a> (OGL). The OGL permits use, re-use or adaption of the licensed work, both commercially and non-commercially.

#### Data quality:

Contributing institutions agree to take responsibility for ensuring that their catalogue descriptions are accurate and are kept up-to-date. Catalogue descriptions should meet The National Archives' guidelines to contributors, including the mandatory fields specified by The National Archives.

### Data protection:

The contributing institution is the Data Controller for any personal data in the catalogue descriptions they submit. Any personal data present in catalogue descriptions is not licensed under the OGL.

## By using MYC, contributing institutions:

- Acknowledge that all catalogue information in Discovery is made available under the terms described above. This
  means the data will be accessible by any member of the public and may be indexed and made available by
  internet search engines.
- Affirm that the descriptions are compliant with current data protection legislation for making available to the public.
- Agree that The National Archives is the Data Controller for the publication, on its website, of the submitted
  catalogue descriptions under the UK-General Data Protection Regulation (UK-GDPR) (2018) and will cease
  publication if it believes this would be a breach of UK-GDPR. The contributing institution remains the Data
  Controller for personal data in the information submitted.
- Agree that <u>The National Archives' Takedown policy</u> applies to the submitted catalogue descriptions, and accept
  that upon receipt of a takedown request, material will be removed by The National Archives and referred to the
  Takedown Panel. The Panel will decide if the material can be restored to The National Archives' website. The
  National Archives will contact the contributing institution upon receipt of a request and will communicate the
  decision of the Takedown Panel. The decision whether to remove material from the contributing organisation's
  own website or catalogue remains with them.
- Understand that The National Archives will not review or alter your descriptions, except in line with the Takedown Policy linked above.
- Agree to contact The National Archives as soon as possible if you discover any submitted data may be in breach
  of data protection legislation. Similarly, if The National Archives discovers a possible breach, we will contact you in
  line with the Takedown policy linked above.
- Understand that if a description removed in line with the Takedown policy is subsequently re-uploaded through MYC, action may be taken against the contributing institution. This may include suspension of access to MYC.

By contributing, you agree to be bound by these terms and conditions.

### Please note:

- If you breach the terms and conditions, The National Archives may delete your contributions and may suspend your account either temporarily or permanently without notice.
- Although all reasonable care will be taken, The National Archives will not be liable for the loss of your data and suggests that you keep a copy of your own data.
- In contributing, you indemnify us against any costs arising from claims made against us for: (a) infringement of any person's Intellectual Property Rights; (b) defamation; or (c) for any other breach of any laws of England and Wales.
- Contributing institutions should be aware that Discovery has an API (Application Programming Interface), which enables data to be provided in a machine-to-machine way, in order to encourage open use and re-use of data. Please see the Re-use of Public Sector Information Regulations for more information.
- In order to contribute please:
  - ensure that you have the right to submit your content in order to reuse it in Discovery under these terms.
  - do not upload any files which could cause damage to a computer, software program, network or server.
